





# **Gha Holding Tokenomics**

The \$GHAHG Tokenomics model has been meticulously designed to support a robust and balanced ecosystem that fosters sustainable growth, investor trust, and community engagement. This comprehensive structure aligns with Gha Holding's strategic objectives across real estate, cryptocurrency exchange, payment processing, and venture capital initiatives. Below, we present a detailed breakdown of the \$GHAHG token allocation, vesting schedule, utility, and strategic goals.

## **Total Token Supply**

Fixed Supply: 1,000,000,000 \$GHAHG

The total supply is capped at one billion tokens, ensuring controlled scarcity and supporting token stability and value retention over the long term.

The fixed supply model enables effective planning of allocations, rewards, and ecosystem expansion while enhancing investor confidence by avoiding inflationary practices.

## Token Allocation

The token allocation is carefully structured to balance the immediate needs for growth, the long-term vision of Gha Holding, and the interests of investors and stakeholders. This allocation plan ensures sufficient funding for development, liquidity for trading, and incentives for holders.







Vesting Schedule (Stacked Area Chart)






# Line Chart (Market Capitalization): Displays the anticipated market cap growth, reflecting the overall expansion of Gha Holding's valuation.

Market Capitalization Growth Over Time (Line Chart)






Bar Chart: Clearly compares the annual yield for each staking tier, making it easy to see the yield progression across Basic, Silver, and Gold levels.

## Staking Tiers and Annual Yield (Bar Chart)






To further support the token's value, Gha Holding will implement a buyback and burn strategy funded by project revenues:

**Burn Mechanism:** Tokens acquired through buybacks will be permanently removed from circulation, decreasing supply and potentially increasing token scarcity over time.



Quarterly Profits and Buyback & Burn Allocation (Stacked Bar Chart)








Stacked Bar Chart: Displays profits with the buyback fund visually stacked on top, illustrating the contribution of the buyback to overall quarterly revenue.

Quarterly Profits and Buyback Fund (Stacked Bar Chart)




Line Chart: Shows the trend of quarterly profits and the corresponding 10% buyback fund over each quarter.




Bar Chart: Displays each milestone's completion percentage, offering a straightforward comparison between different phases.

#### GHA Holding Project Roadmap (Bar Chart)




Line Chart: Illustrates the progression of project completion across key milestones, providing a clear view of each phase's advancement.

## Gha Holding Roadmap: A Detailed Vision for the Future

2024: The Foundation Year – Building the Core

#### Q1 2024: Preparation and Structuring

Finalize the development of the \$GHAHG token smart contract, ensuring it is aligned with best practices for security and utility. Begin designing the Gha Holding Whitepaper and defining the tokenomics, staking models, and vesting schedules. Form strategic partnerships with blockchain developers and financial institutions to establish the foundation of the ecosystem. Initiate the registration and licensing process for operating in Dubai, including compliance with UAE regulations. Launch social media channels (Twitter, Telegram, LinkedIn) to build an initial community and generate awareness.

#### Q2 2024: Transparency and Development

Engage with industry-leading auditors, such as Certik, to begin auditing the \$GHAHG smart contract for security and compliance. Complete the design and development of the official Gha Holding Website, ensuring it includes key sections like Whitepaper, Roadmap, Tokenomics, and a staking interface. Expand community engagement with targeted campaigns to onboard early followers and investors. Develop a robust marketing strategy for the direct token listing.

#### Q3 2024: Pre-Launch Preparations

Launch the Gha Holding Website and staking platform, enabling users to start staking \$GHAHG tokens. Begin community-driven campaigns to promote staking and ecosystem engagement. Publish the audit report for \$GHAHG to ensure trust and transparency among investors.

Introduce staking rewards for real estate investors who lock their tokens into real estate pools.

Develop educational content and workshops to introduce blockchain-based real estate to traditional investors.

#### Q3 2025: Development of GHA Exchange

Begin the development of GHA Exchange, a cryptocurrency trading platform focusing on security, speed, and user experience. Onboard liquidity providers and establish partnerships to ensure a robust trading experience. Alpha test the exchange with selected users, gathering feedback for improvements.

#### Q4 2025: Beta Launch of GHA Exchange
